The HKCMC respects your privacy rights when collecting, storing, using and transferring your personal data, and is committed to ensuring that the processing of all relevant personal data is in compliance with the data protection principles and all relevant provisions of the Personal Data (Privacy) Ordinance, Chapter 486 of the laws of Hong Kong Special Administrative Region (the "Ordinance").
